Tuition Agreement

- FALL SEASON - Tuition (**Monthly Billing**) will be due on the 1st of the month for 8 months from September or (upon registration) through June. **Tuition will not be collected in February or June.** A \$10 late fee will be automatically added to the balance after the 10th of the month. **OPTION #2 (Quarterly Billing)** Tuition will be due 4 times throughout the season. Quarterly tuition will be collected in September or (upon registration), November, January, and April. If payment isn't received by the 10th of the month a \$20 late payment will automatically be added to the balance.
- Tuition is based on a yearly program and is broken into convenient sessions. - monthly or quarterly fees remain the same from September through June whether the month is 3 weeks long or 5 weeks long.
- SUMMER SESSIONS & CAMPS - Tuition is due upon enrollment.
- Returned checks will carry a \$30 fee. After two returned checks you will be required to pay with cash, money order (made out to BSDPA), or credit card.
- **To avoid unnecessary Tuition charges, a request to withdraw from classes must be submitted through email. You WILL be obligated to pay until such a request is submitted.**
- If you withdraw from a class after the performance costume has been ordered, **you will still be responsible for the full costume payment.**
- I understand that Brockport School of Dance & Performing Arts does not give credit and/or refunds for class(es) missed due to holidays, vacations, illness, weather, etc.

Refunds:

Registration fees are non-refundable. There will be no refunds made if your child misses a class; however, they may make up the class at any age-appropriate class. If we cancel a class due to teacher illness, we will arrange a make-up time. We will not provide make-up classes for weather emergencies. Dancers are welcome to attend a make-up class at any age-appropriate class for weather-related cancellations.

After October 1st, Sr. level dancers' tuition will not be refunded for monthly or quarterly payment plans, if the dancer unenrolls from a class. You will not be responsible for future tuition payments but refunds will not be given within the session. Dancers who unenroll in our Twinkle Babies; Twinkle Stars; and Show Stars levels can still receive an in-session refund. Please note there will be a \$10 class cancellation fee and a refund will be sent in the form of a check to the address on file. If the amount is less than \$10, a credit will remain on the account instead. A refund check will not be sent if the refund amount is under \$10.

Costume Deposits are non-refundable once the costumes have been ordered and families will still be responsible for the final costume cost.

SR LEVEL ATTENDANCE: Dance training takes consistency. Classes progress through our curriculum with weekly and monthly goals. Regular attendance is essential to a student's progress, especially once in the Sr. Levels. Missing class means missing

important technique and choreography. This affects not only the dancer but everyone in the class. SR-level dancers with poor attendance may be asked to sit out of performances; certain choreography sections (missed while out), or asked to schedule a makeup class at the expense of the dancer.

We understand that illness and injuries happened. However, we do expect SR-level dancers to communicate with our staff in regard to attendance. A doctor's note is required for dancers missing more than one week of classes due to illness or injury.

Dress Code:

Dressing properly for class is part of the discipline required for dance. Specific requirements per class are addressed in our class dress code guide. Students who do not comply with our dress code will be given a warning. If a student continually dresses inappropriately they will be asked to sit out or will need to borrow a studio issues leotard and tights.

Media Release:

I hereby authorize Brockport School of Dance and Performing Arts to record my and/or my child's/children's picture and voice, to edit these recordings at its discretion, and to incorporate these recordings into movie and sound films. Examples of use are choreographic records, performance DVDs, practice videos posted online, promotional photos, and print advertising. I acknowledge that no promises of compensation were made by Brockport School of Dance and Performing Arts.

Liability Release:

I am aware that dance training and the athletic exercises associated with it place unusual stress on the body and carry the risk of physical injury. On behalf of my child and myself (and if I am no longer a minor, on my own behalf), I assume the risk and agree that Brockport School of Dance and Performing Arts shall not be liable in any way for injuries sustained during attendance at the school or any of its related functions. I also understand that good dance training involves the adjustment of the student's body by the instructor. I further understand that there are specific risks of physical or property damages, losses, or injury that may result from my or my child's participation with Brockport School of Dance & Performing Arts, and I voluntarily assume the risks associated with such participation.

COVID-19& Illness

ACKNOWLEDGMENT AND DISCLOSURE OF STUDENT / FAMILY

I understand that to enter the studio premises my child must be free from COVID-19 or any other flu-like illness. All dancers and guests must stay home if they are feeling ill.

Symptoms include:

- Fever of 100.4 degrees Fahrenheit or higher
- Dry cough
- Shortness of Breath
- Chills
- Loss of taste or smell
- Sore Throat
- Muscle aches

Dancers who might be feeling under the weather (mild cold symptoms) but are able to dance or are returning from being sick are welcome to wear a mask in class.

Each student and guest MUST remove their shoes at the entrance (hallway) of the facility and be properly dressed for class.

I understand that Students entering our studio will be in contact with children, families, and employees who are also at risk of community exposure. I understand that no list of restrictions, guidelines, or practices will remove 100% of the risk of exposure to COVID-19 as the virus can be transmitted by persons who are asymptomatic and before some people show signs of infection. I understand that I play a crucial role in keeping everyone in the facility safe and reducing the risk of exposure by following the practices outlined herein. I agree to not hold Brockport School of Dance and Performing Arts, LLC liable if my child or any family member becomes sick after attending a class or event held by the studio.

Should there be a medical or natural emergency, and we are forced into a NY on Pause situation, all classes will continue virtually. Tuition will remain the same for any amount of time spent doing virtual classes. I understand that BSDPA will update me via email with any changes to its policies throughout the season.

I certify that I have read, understand, and agree to comply with the provisions listed herein. I acknowledge that failure to act in accordance with the provisions listed herein, or with any other policy or procedure outlined by Brockport School of Dance and Performing Arts, LLC will result in disciplinary action up to and including termination of my registration at Brockport School of Dance and Performing Arts, LLC.
